Dear Minister

I am writing to convey the outcomes of the 49<sup>th</sup> meeting of the Sydney Airport Community Forum (SACF) held on 9 March 2006.

The members noted your rejection of SACL's Draft Major Development Plan for the construction of an outlet centre and bulky goods and discount store.

Further, members noted the recent release of the Australian National Audit Office (ANAO) report on the Implementation of the *Sydney Demand Management Act 1997*. As the report was only tabled two days before SACF met, SACF has postponed a detailed discussion of the report until the next meeting in June.

Unfortunately, the initial tender process for the role of the Aviation Community Advocate (ACA) was unsuccessful; however I am optimistic that SACF and the Department will be successfully re-tendering the position shortly. The Tender Evaluation Committee agreed in January 2007 that it was necessary to revise the selection criteria for the ACA role. To aid this process, a subcommittee of SACF members has been formed to clarify the outstanding details.

Although we have not yet been able to meet to discuss the issue of insulation for Kurnell, I look forward to speaking with you at your earliest convenience.
