Dear Minister

I am writing to report on outcomes of the meeting of the Sydney Airport Community Forum (SACF) held on 24 May 2013.

The Forum was given an informative presentation on the findings of the scoping study of Wilton and RAAF Base Richmond for civil aviation operations.

Representatives of the Sydney Airport Corporation Limited (SACL) then outlined the consultation process for the Preliminary Draft Master Plan for 2033 (PDMP) and advised that it would be released in the near future. The Forum expressed concern about the effects of continued growth in aircraft movements at Sydney Airport, and seeks your reassurance that the noise sharing arrangements in the Long Term Operating Plan (LTOP) will be protected.

The Forum resolved to request that you provide funding to engage a suitably qualified expert to assist in preparing SACF's response to the PDMP. In a letter dated 1 September 2009 you indicated that you would be prepared to consider such requests for assistance. The Forum seeks your response to this request prior to its next meeting on 12 July 2013.
