AGENDA ITEM 1 Opening Remarks and Adoption of Agenda

The Agenda was adopted without change.

The Chair read out a letter from the Minister for Infrastructure and Transport responding to a request for funding to engage a suitably qualified expert to assist SACF in preparing a response to the Sydney Airport Preliminary Draft Master Plan. The Minister declined this request and encouraged the Forum to make use of the resources of the Department and Airservices Australia in preparing a submission.

Action 1 The Secretariat to circulate the letter from the Minister.

AGENDA ITEM 2 SACF Presentation on the Preliminary Draft Master Plan (PDMP)

Mr Plummer gave a presentation on the Sydney Airport PDMP.

AGENDA ITEM 3 Presentation on a draft SACF submission on the PDMP

Mr Stone made a presentation outlining a framework for a draft SACF submission on the PDMP which highlighted some of the differences in forecasts between the PDMP and the *Joint Study on aviation capacity in the Sydney region*.

Action 2 The Secretariat to circulate a copy of the presentation on the draft SACF submission.

AGENDA ITEM 4 Discussion on the development of the SACF submission.

There was discussion of the impact of the forecast increase in passenger numbers on ground traffic and the potential for road traffic congestion to impact surrounding suburbs.

The Chair noted that action needs to be taken to ensure that noise sharing is protected, and that there is an urgent need for construction of a second Sydney airport to be commenced as soon as possible.

Action 3 The Secretariat to circulate the table prepared by Airservices outlining the capacity of the noise sharing runway modes.

Action 4 Members to provide written comments for inclusion in the SACF submission to the Secretariat by 29 July 2013.

It was agreed that a draft SACF submission would be presented for discussion at the next SACF meeting on Friday 2 August 2013, and further comments could be provided.
