I am writing in regard to the meeting of the Sydney Airport Community Forum held on 31 August 2012.

Airservices Australia gave a presentation about a planned upgrade to the internet information tool WebTrak which is designed to provide more information to users.

Airservices also reported on its review of noise monitoring, and the Forum agreed to make temporary noise monitors at Hunters Hill and Leichhardt permanent and deploy further temporary noise monitors in noise sensitive areas.

The Sydney Airport Corporation Limited provided a briefing on a major development plan to construct an aircraft maintenance hangar, and an update on the process for developing the next Master Plan for Sydney Airport.
