Dear Minister

I am writing to convey the key outcomes of the meeting of the Sydney Airport Community Forum (SACF) held on 21 May 2010. In doing so I would like to thank you for your address to members at the beginning of the meeting, where you were able to outline your position on a range of issues.

Sydney Airport Corporation Ltd. reiterated that the RESA project had now been completed, however this had coincided with an increase in complaints from those residents who live under the 07/25 runway flight path. In early April, a 'Project Completed' pamphlet was distributed to more than 100,000 households around the airport informing them that RESA had been successfully completed and that LTOP Mode 15 is no longer being used.

Discussion once again continued on the noise over Cook and Lowe, with Airservices agreeing to investigate the issue further for the committee.

The issue of the ongoing role of the LTOP Implementation Monitoring Committee (IMC), a sub-committee of SACF, was raised during the meeting. The Department has agreed to conduct a desktop review of the sub-committee, looking into its role and reporting structures, to determine whether IMC needs to be realigned with its original Terms of Reference.

SACF members endorsed the Terms of Reference that were drafted by Airservices and the Department on a joint study into new technology, to examine the potential for introducing new navigation technologies to assist noise sharing. I have forwarded the draft Terms of Reference to you for consideration in separate correspondence of 27 May 2010. Some SACF members raised concerns about housing developments that are being proposed close to Sydney Airport, under major flight paths. Developments of particular interest are those of the Australand Development at Kurnell, which is under a 24 hour flight path (over Botany Bay), and a housing development in Eastlakes (at the end of runway 07).

Airservices Australia has issued an invitation for SACF members to tour the Sydney facilities to enable members to gain a better understanding of the operations of Airservices in Sydney. This tour is proposed for 23 July 2010.

The Forum will next meet on Friday, 20 August 2010.
